DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-175)

WHEREAS, Purchase Request No. 202310289 (Annex A) was received on 04 October 2023 for the **SUPPLY AND DELIVERY OF FLOOR TILES AND ACCESSORIES** with approved budget for the contract in the amount of **SEVEN HUNDRED SEVENTY EIGHT THOUSAND PESOS (₱778,000.00)**;

WHEREAS, Request for Quotation No. 2023-102 was posted in PhilGEPS on 06 October 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 06 October 2023, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

WHEREAS, on or before the deadline to submit quotations – i.e. 11 October 2023, 5:00 P.M. – the below quotations were received and opened (Annex D is Abstract of Quotation):

WHEREAS, on 06 November 2023, Buildtrade Construction Supply withdrew its bid (Annex E is the copy of electronic mail);

WHEREAS, after verification and validation of the accepted proposal (Annex F is Evaluation Report), it was determined that the quotation of Nallex Construction Supplies Trading in the amount of **FOUR HUNDRED NINETY-NINE THOUSAND TWENTY FIVE PESOS (₱499,025.00)** is the lowest calculated and responsive quotation for the subject procurement.
