### DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-184)

**WHEREAS**, Purchase Request No. 202309278 (Annex A) was received on 28 September 2023 for the **PROCUREMENT OF SERVER AND OTHER RELATED EQUIPMENT FOR THE SEC LIBRARY** with approved budget for the contract in the amount of **One Million Pesos (₱ 1,000,000.00)**;

**WHEREAS**, Request for Quotation AMP No. 2023-126 was posted in PhilGEPS on 29 November 2023 for the abovementioned procurement (Annex C is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
