



DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-172)

WHEREAS, Purchase Request No. 202309278 (Annex A) were received on 28 September 2023 for the **PROCUREMENT OF DIGITALIZATION PROJECT FOR THE SEC LIBRARY (Lot 3- Supply and Delivery of Integrated Library System [ILS] with RFID and Security System for SEC Library)** with approved budget for the contract in the amount of **Two Million Five Hundred Thousand Pesos (₱2,500,000.00)**;

WHEREAS, the Invitation to Bid and the bidding documents for the **PROCUREMENT OF DIGITALIZATION PROJECT FOR THE SEC LIBRARY** under Public Bidding No. 2023-011 was posted in PhilGEPS on 6 October 2023 for the abovementioned procurement. The same Invitation to Bid was posted in Securities and Exchange Commission (SEC) website and in conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 27 October 2023;

WHEREAS, on or before the deadline, the following contractor/bidder submitted bid for lot 3 with corresponding remarks/rating;

WHEREAS, after the necessary bid evaluation on 27 October 2023, the bid of **WISERF TECHNOLOGIES, INC. (WISERF)**, was determined and declared as the Single/Lowest Calculated Bid, and notice was sent to the latter requiring the submission post-qualification documents;

WHEREAS, on 10 November 2023 and after post-qualification, the bid of WISERF, was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;


NOW, THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following:

1. To declare the bid of WISERF in the amount of **Two Million Four Hundred Eighty-Six Thousand Pesos (₱2,486,000.00)**, all inclusive of VAT and applicable taxes, as the Single/Lowest Calculated and Responsive Bid for the above-mentioned project; and
2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **PROCUREMENT OF DIGITALIZATION PROJECT FOR THE SEC LIBRARY** under Public Bidding No. 2023-011, be awarded to WISERF.
