**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2023-174)

**WHEREAS**, Purchase Request No. 2023-10291 (Annex A) was received on 06 October 2023 for the **BUS RENTAL FOR THE CONDUCT OF 2023 COMMISSION-WIDE SUPERVISION 2028 PERFORMANCE REVIEW AND INTERNAL TARGETS UPDATING (SPRINT) CONFERENCE** with approved budget for the contract in the amount of **FOUR HUNDRED THIRTY THOUSAND PESOS (P430,000.00)**;

**WHEREAS**, Request for Quotation Amp No. 2023-121 (Reposting) was posted in PhilGEPS on 11 November 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 11 November 2023, invited (Annex C is proof) the legally, technically, and financially capable service providers;

**WHEREAS**, on or before the deadline to submit quotations- i.e., 14 November 2023, 12:00 P.M, the following quotations were received and opened (Annex D is Abstract of Quotation):

**WHEREAS**, after verification and validation of the lowest calculated quotation, it was determined that M&C Travel and Tours was not compliant with the requirement for an LTFRB Certificate for Public Convenience (Annex E are Evaluation Report);


**WHEREAS**, Fineline Tours and Travel Services was found to be not compliant with the required number of buses (Annex F is proof), hence, the quotation was declared disqualified;

**WHEREAS**, Genesis Transport Service Inc.'s quotation, in the amount of **FOUR HUNDRED THIRTY THOUSAND PESOS (P430,000.00)**, was determined to be the lowest calculated and responsive quotation for the subject procurement (Annex G is the Evaluation Report);

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **GENESIS TRANSPORT SERVICE INC.** in the amount of **FOUR HUNDRED THIRTY THOUSAND PESOS (P430,000.00)** as the lowest calculated and responsive quotation for the **BUS RENTAL FOR THE CONDUCT OF 2023 COMMISSION-WIDE SUPERVISION 2028 PERFORMANCE REVIEW AND INTERNAL TARGETS UPDATING (SPRINT) CONFERENCE**, and to recommend to the Head of the Procuring Entity the award of contract to the same contractor/bidder in accordance with the terms and conditions of the Request for Quotation AMP No. 2023-121 (reposting) and accepted quotation.
