DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, Purchase Request No. 2023-10-284 (Annex A) was received on 4 October 2023 for **TRANSPORT AND HAULING SERVICES FOR THE TRANSFER OF SEC PROPERTIES** with approved budget for the contract in the amount of **TWO HUNDRED FIFTY THOUSAND PESOS (Php 250,000.00)**;
