DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, Purchase Request No. 202310299 (Annex A) was received on 17 October 2023 for the **SUPPLY, DELIVERY AND INSTALLATION OF CUSTOMIZED OFFICE CUBICLE PANEL PARTITIONS FOR THE SEC CAGAYAN DE ORO EXTENSION OFFICE** with approved budget for the contract in the amount of **Eighty Thousand Pesos (P80,000.00)**;


