DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-105)

WHEREAS, Purchase Request No. 2023-05-178 (Annex A) was received on 05 July 2023 for **SUPPLY AND DELIVERY OF TUMBLERS, ID LACE WITH CARD HOLDER AND MUGS WITH LID AND SIP LOGO FOR SEC INTERNS** with approved budget for the contract in the amount of **SIXTY SEVEN THOUSAND FIVE HUNDRED PESOS (Php 67,500.00)**;

WHEREAS, Request for Quotation AMP No. 2023-066 was posted in PhilGEPS on 08 July 2023 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;


