DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-008)

WHEREAS, Purchase Request No. 202401003 (Annex A) was received on 11 January 2024 for the **Supply and Delivery of Multimedia Equipment and Accessories** with approved budget for the contract in the amount of **Four Hundred Thirty Thousand Pesos (Php430,000.00)**;

WHEREAS, Request for Quotation No. 2024-005 was posted in PhilGEPS on 18 January 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
