DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2023-186)

WHEREAS, Purchase Request No. 202310304 (Annex A) was received on 13 October 2023 for the **HOSTING/CO-LOCATION FACILITY OF SEC (“Project”)** with an approved budget for the contract of **TWELVE MILLION PESOS (Php 12,000,000.00)**;

WHEREAS, the Project was undertaken as an **Early Procurement Activity (EPA)** in accordance with GPPB Resolution No. 14-2019 and other related rules and regulations;

WHEREAS, the Invitation to Bid and the bidding documents for the Project under Public Bidding 2023-040 was posted in PhilGEPS on 19 October 2023 for the abovementioned procurement. The same IB was posted on the Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of the SEC on the same date;

WHEREAS, all the mandatory activities before the deadline to submit the bids were undertaken and the deadline to submit was scheduled on 10 November 2023;

WHEREAS, on or before the deadline, only the following bidder submitted its bid with corresponding remark/rating;

WHEREAS, after the necessary bid evaluation on 10 November 2023, the bid of **Eastern Telecommunications Philippines, Inc.** was determined and declared as the Single Calculated Bid and notice was sent to the latter requiring the submission of post-qualification documents;



2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **HOSTING/CO-LOCATION FACILITY OF SEC** under Public Bidding No. 2023-040 be awarded to **Eastern Telecommunications Philippines, Inc.**




