AGREEMENT No. 2024-3-001

THIS AGREEMENT made the 29th day of December 2023 between **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at SEC Headquarters, 7907 Makati Avenue, Salcedo Village, Bel-Air, Makati City, represented herein by its Information and Communications Technology Department Director, OLIVER V. CHATO, of the one part, and **SVI SOFTWARE SERVICES CORPORATION**, herein represented by its EV, JAE ALVIN ISIDORE M. GUANIO, with office address at #3 Julia Vargas Avenue, Ortigas Center Pasig City (hereinafter called "the Service Provider"), of the other part;

WHEREAS, the Entity is desirous that the Service Provider execute the Subscription to Online Document Retrieval System ("the Work"), and the Entity and the Service Provider have agreed for the contract price in the sum of Six Million Eight Hundred Seventy Five Thousand Pesos (Php6,875,000.00), inclusive of VAT, by the Service Provider for the execution and completion of such Works and remedying of any defect therein;

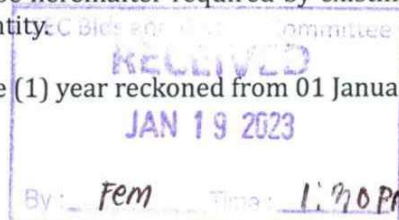
WHEREAS, the Work has been determined to be a regular or recurring services as defined under Appendix 37 of the revised implementing rules and regulations of Republic Act No. 9184, or the Guidelines on the Renewal of Regular and Recurring Services;

WHEREAS, under the aforementioned Guidelines, renewal of existing contract may be resorted to subject to compliance to conditions and without the need to resort to Public Bidding as procurement modality;


WHEREAS, in its Resolution on 29 December 2023, the BAC recommended the renewal of the existing contract inasmuch as the conditions for the renewal of contract have been determined to be existing or present.

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of the Original Agreement.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as integral part of this Agreement, viz.:
 - a. The Original Agreement (copy is attached and made integral part hereof);
 - b. Performance Security;
 - c. Notice of Renewal with Service Provider's Conformity; and
 - d. Other documents that may be hereinafter required by existing rules and regulations and/or by the Entity.
3. The Agreement shall have a term of one (1) year reckoned from 01 January 2024.




