

CONTRACT AGREEMENT NO. 2024-03-010

THIS AGREEMENT made this 1st day of February 2024 between the **SECURITIES AND EXCHANGE COMMISSION** (hereinafter called "the Entity"), with office address at SEC Headquarters, Makati Avenue, Salcedo Village, Makati City, represented herein by, FILBERT CATALINO F. FLORES III, HRAD DIRECTOR, of the one part, and the **POWER HOUSE PEST CONTROL SERVICES**, represented herein by ANNA MARIE M. ESCOBER, AUTHORIZED REPRESENTATIVE, with office address at R. Fernandez St. Gagalangin 2422, Barangay 166 Tondo I/II, NCR, City of Manila, Philippines (hereinafter called "the Service Provider") of the other part;

WHEREAS, the Entity invited Quotations for the Pest Control Services for the SEC Headquarters and has accepted the Proposal by the Service Provider in the sum of *Four Hundred Twenty-Three Thousand Seven Hundred Seventy-Seven Pesos (Php 423,777.00)* (hereinafter called "the Contract Price").

NOW THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as part of this Agreement, to wit:
 - (a) Terms of Reference;
 - (b) Request for Quotation;
 - (c) The Winning Bidder's proposal, including the Eligibility requirements, documents and/or statements submitted;
 - (d) Notice of Award of Contract and the Servicing Agency's conforme thereto; and
 - (e) Other contract documents that may be required by existing laws and/or the Entity
3. In consideration for the sum of the Contract Price or such other sums as may be ascertained, the Service Provider agrees to provide the Project in accordance with his/her/its Proposal
4. The Entity agrees to pay the above-mentioned sum in accordance with the terms of the Proposal


