ELIGIBILITY CHECKING AND RECOMMENDING SHORTLIST OF CONSULTANT/S
(Resolution No. 2024-014)

WHEREAS, Purchase Request No. 202401030 was received 17 January 2024 for **the PROCUREMENT OF CONSULTING SERVICES FOR THE CONCEPT, DESIGN, AND PRINTING OF THE SEC LEGACY COFFEE TABLE BOOK ("Project")** with approved budget for the contract in the amount of **FIVE MILLION FIVE HUNDRED THOUSAND PESOS (Php 5,500,000.00)**;

WHEREAS, the Request for Expression of Interest and the Bidding Documents for Project under Public Bidding No. 2024-002 was posted in PhilGEPS on 20 January 2024 for the abovementioned procurement. The same REI was posted in Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of SEC on same date;

WHEREAS, all the mandatory activities before the deadline to submit eligibility documents were undertaken and the deadline to submit eligibility documents was scheduled on 29 January 2024, 10:00 AM;

WHEREAS, on or before the deadline, the following bidders submitted their eligibility documents;

1. Studio 5 Designs, Inc.;
2. Red Root Artists and Artisan Multi-Purpose Cooperative; and
3. Coms 360, Inc.

WHEREAS, after the conduct of eligibility checking, it was determined that Coms 360, Inc., was **ineligible** due to non-submission of a valid PhilGEPS Platinum Certificate;

WHEREAS, the following bidders received the corresponding ratings during the shortlisting:

Company	Rating / Remarks
Studio 5 Designs, Inc.	84.17
Red Root Artists and Artisan Multi-Purpose Cooperative	60.40

WHEREAS, Red Root Artists and Artisan Multi-Purpose Cooperative failed to reach the minimum rating requirement of 70 points;

NOW THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following:

1. to declare Studio 5 Designs, Inc., eligible to bid for the Procurement of Consulting Services for the Concept, Design, and Printing of the SEC Legacy Coffee Table Book; and
2. to recommend to the Head of the Procuring Entity/Authorized Representative the inclusion of Studio 5 Designs, Inc., in the shortlist.


