**DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-030)

**WHEREAS**, Purchase Request No. 202401048 (Annex A) was received on 19 January 2024 for the **Supply and Delivery of Medicines, Medical and Dental Supplies** with approved budget for the contract in the amount of **Eight Hundred Thousand Pesos (Php800,000.00)**;

**WHEREAS**, Request for Quotation No. 2024-017 was posted in PhilGEPS on 2 February 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 2 February 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;

**WHEREAS**, on or before the deadline to submit quotation/s, 8 February 2024, 10:00 AM – the below quotations were received and opened (Annex D is Abstract of Quotation):

**WHEREAS**, after verification and validation of the proposal on 13 Feb. 2024 (Annex E is Evaluation Report), it was determined that:

1. the quotation of **Ayamed Drug Distributor** for lot 1, in the amount of **Two Hundred One Thousand Fifty Pesos (₱201,050.00)** is the single/lowest calculated and responsive quotation for the subject procurement;
2. the quotation of **Ayamed Drug Distributor** for lot 2 is not compliant with the requirement to indicate brand/s offered; and
3. the quotation of **Bio-Dent Medical Equipment Trading** for lot 2, in the amount of **Four Hundred Thirty-Eight Thousand Pesos (₱438,000.00)** is the single/lowest calculated and responsive quotation for the subject procurement.
