DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-037)

WHEREAS, Purchase Request No. 202401063 (Annex A) was received on 01 February 2024 for the Supply and Delivery of Full Duplex Wireless Intercom System Package with Eight (8) Headsets with approved budget for the contract in the amount of Two Hundred Thousand Pesos (Php200,000.00);

WHEREAS, Request for Quotation No. 2024-028 was posted in PhilGEPS on 07 February 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 07 February 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;
