DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

WHEREAS, Purchase Request No. 202401021 (Annex A) was received on 30 January 2024 for the **Subscription to Media Monitoring Services for One (1) Year** with approved budget for the contract in the amount of **Six Hundred Thousand Pesos (Php600,000.00)**;

WHEREAS, Request for Quotation No. 2024-026 was posted in PhilGEPS on 07 February 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 07 February 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;


