### DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-006)

**WHEREAS**, Purchase Request No. 202401018 (Annex A) was received on 19 January 2024 for the **SUPPLY AND DELIVERY OF BRANDED MONITORS FOR PROGRAMMERS/DEVELOPERS** with approved budget for the contract in the amount of **THREE HUNDRED SIXTY-EIGHT THOUSAND PESOS (Php 368,000.00)**;


**WHEREAS**, Request for Quotation No. AMP 2024-008 was posted in PhilGEPS on 20 January 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 20 January 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers/contractors;


