### DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-011)

**WHEREAS**, Purchase Request No. 202401004 (Annex A) was received on 11 January 2024 for the **Pest Control Services for the SEC Headquarters** with approved budget for the contract in the amount of **Nine Hundred Two Thousand Pesos (Php 902,000.00)**;

**WHEREAS**, Request for Quotation No. 2024-001 was posted in PhilGEPS on 18 January 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 18 January 2024, invited (Annex C is proof) the legally, technically, and financially capable service providers;

**WHEREAS**, on or before the deadline to submit quotations- i.e., 23 January 2024, 10AM – the following quotations were received and opened (Annex D is Abstract of Quotation):

**WHEREAS**, after verification and validation of all accepted proposals on 25 January 2024 (Annex E are the Evaluation Reports), it was determined that the quotation of **Power House Pest Control Services** in the amount of **FOUR HUNDRED TWENTY-THREE THOUSAND SEVEN HUNDRED SEVENTY-SEVEN PESOS (₱423,777.00)** is the lowest calculated and responsive quotation for the subject procurement.

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **Power House Pest Control Services** in the amount of **FOUR HUNDRED TWENTY-THREE THOUSAND SEVEN HUNDRED SEVENTY SEVEN PESOS (₱423,777.00)** as lowest calculated and responsive quotation for the **PEST CONTROL SERVICES FOR THE SEC HEADQUARTERS**, and to recommend to the Head of the Procuring Entity the award of contract to the same service provider in accordance with the terms and conditions of the Request for Quotation No. 2024-001 and accepted quotation.
