WHEREAS, Purchase Request Nos. 202401050 and 202401051 (Annex A) were received on 19 January 2024 for the **SUPPLY AND DELIVERY OF CONFERENCE FOLDERS, ID CASE WITH STRETCHABLE LANYARDS, VELLUM BOARDS AND CANVASS TOTE BAGS FOR THE SEC ROADSHOW PARTICIPANTS** with total approved budget for the contract in the amount of **EIGHT HUNDRED EIGHTY THOUSAND PESOS (Php 880,000.00)**;
