DECLARATION OF LOWEST/SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-031)

WHEREAS, Purchase Request No. 202401040 (Annex A) was received on 29 January 2024 for the **SUPPLY AND DELIVERY OF CONFERENCE TABLE AND CHAIRS** with approved budget for the contract in the amount of **One Hundred Sixty-Five Thousand Pesos (Php 165,000.00)**;

WHEREAS, Request for Quotation AMP No. 2024-022, was posted in PhilGEPS on 02 February 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 02 February 2024 invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations- i.e., 07 February 2024, 10:00AM – the following quotations were received and opened (Annex D is Abstract of Quotation):

WHEREAS, after verification and validation of accepted proposals (Annex E is Evaluation Report), it was determined that the quotations of **See Manufacturing Contractor** and **MKS Furniture** were non-compliant with the minimum technical requirements of the project;

WHEREAS, it was also determined that the quotation of **DOIN Furniture Trading** in the amount of **One Hundred Thirty-Three Thousand Nine Hundred Eighty Pesos (P133,980.00)** is the lowest calculated and responsive quotation for the subject procurement;

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of DOIN Furniture Trading, in the amount of **One Hundred Thirty-Three Thousand Nine Hundred Eighty Pesos (P133,980.00)** as lowest calculated and responsive quotation for the **SUPPLY AND DELIVERY OF CONFERENCE TABLE AND CHAIRS**, and to recommend to the Head of the Procuring Entity the award of contract to the same supplier in accordance with the terms and conditions of the Request for Quotation AMP No. 2024-022 and accepted quotation.
