DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-029)

WHEREAS, Purchase Request No. 202401034 (Annex A) was received on 19 January 2024 for the **Supply and Delivery of Tumblers, Lanyard, Mugs with Lid and Flash Drive for SEC Internship Program** with approved budget for the contract in the amount of **Three Hundred Thousand Pesos (Php300,000.00)**;

WHEREAS, Request for Quotation No. 2024-013 was posted in PhilGEPS on 23 January 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 18 January 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations, 31 January 2024, 10:00 AM – the following quotations were received and opened (Annex D is Abstract of Quotation):

WHEREAS, in its Resolution No. 2024-027 (Annex E), the Bids and Awards Committee recommended the award of contract to **3P Printing Services** in the amount of **Two Hundred Fifteen Thousand Four Hundred Pesos (P215,400.00)** and the Notice of Award was subsequently issued on 12 February 2024;


WHEREAS, 3P Printing Services, through its electronic mail on 12 February 2024, refused to receive the award (Annex F);

WHEREAS, after verification and validation of the second lowest calculated proposal on 21 February 2024 (Annex E is Evaluation Report), it was determined that the quotation of **D.E. Curtain Shop** in the amount of **Two Hundred Twenty Thousand Two Hundred Pesos (P220,200.00)** is the lowest calculated and responsive quotation for the subject procurement.

NOW, THEREFORE, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **D.E. Curtain Shop** in the amount of **Two Hundred Twenty Thousand Two Hundred Pesos (P220,200.00)** as the lowest calculated and responsive quotation for the **Supply and Delivery of Tumblers, Lanyard, Mugs with Lid and Flash Drive for SEC Internship Program**, and to recommend to the Head of the Procuring Entity the award of contract to the same bidder in accordance with the terms and conditions of the Request for Quotation No. AMP 2024-013 and accepted quotation.
