**WHEREAS**, Purchase Request No. 202402111 was received on 27 February 2024 for the engagement of a **Highly Technical Consultant for the Office of Commissioner Karlo S. Bello** with an approved budget for the contract of **Seven Hundred Eighty Thousand Pesos (Php780,000.00)**;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the End-User Unit justified to the Bids and Awards Committee (BAC) that the engagement of the individual consultant is in accordance with the conditions set forth in Section V.D.7.a of Annex "H" of the same law;





**NOW, THEREFORE**, on the basis of the foregoing, the Bids and Awards Committee **RESOLVES** to recommend to the Head of the Procuring Entity or his authorized representative the award of contract to **Mr. Renato A. Santos**, as **Consultant for the Office of Commissioner Karlo S. Bello** in the amount of **Three Hundred Ninety Thousand Pesos (Php 390,000.00)** for a period of **Six (6) months**, inclusive of VAT and subject to compliance to reportorial requirements as stated in Terms of Reference.
