### **RECOMMENDING AWARD OF CONTRACT FOR THE ENGAGEMENT OF A HIGHLY TECHNICAL CONSULTANT FOR A PERIOD OF SIX (6) MONTHS**

**WHEREAS**, Purchase Request No. 202402092 was received on ~~15~~ February 2024 for the hiring of a **Highly Technical Consultant for the Proposed Renovation of Several Floors of the SEC Headquarters** with an approved budget for the contract of **Nine Hundred Thousand Pesos (Php900,000.00)**;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the End-User Unit justified to the Bids and Awards Committee (BAC) that the engagement of the individual consultant is in accordance with the conditions set forth in Section V.D.7.a of Annex "H" of the same law;

**WHEREAS**, the BAC, after assessment of all documents submitted - *i.e. Terms of Reference and justification for the engagement of Mr. Kim Villa Policarpio*, has determined that the above requirement is included in the FY 2024 Annual Procurement Plan (APP) of the Securities and Exchange Commission;

**WHEREAS**, the BAC, after its evaluation, has determined that all documents submitted are acceptable, and that Mr. Policarpio is legally, financially, and technically capable to undertake and fulfill the required services;

**NOW, THEREFORE**, on the basis of the foregoing, the Bids and Awards Committee **RESOLVES** to recommend to Head of the Procuring Entity or his authorized representative the award of contract to **Kim Villa Policarpio**, as a consultant **for the Proposed Renovation of Several Floors of the SEC Headquarters** in the amount of **Nine Hundred Thousand Pesos (Php900,000.00)** for a period of **six (6) months**, inclusive of VAT and subject to compliance to reportorial requirements as stated in Terms of Reference.
