WHEREAS, Purchase Request No. 202401079 (Annex A) was received on 2 February 2024 for the **SUBSCRIPTION OF MEDIA PRODUCTION SOFTWARE COLLECTION ("Project")** with approved budget for the contract in the amount of **One Million Three Hundred Fifty-Nine Thousand Nine Hundred Ninety-Six Pesos (Php 1,359,996.00)**;




