**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND
RECOMMENDING AWARD OF CONTRACT**

WHEREAS, Purchase Request No. 202403132 (Annex A) was received on 02 April 2024 for the **Supply and Delivery of Corrugated Boxes** with an approved budget for the contract in the amount of **THREE HUNDRED THOUSAND PESOS (P300,000.00)**:

WHEREAS, Request for Quotation AMP No. 2024-040 was posted in PhilGEPS on 03 April 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 03 April 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;


