### **DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-062)

**WHEREAS**, Purchase Request No. 20242097 (Annex A) was received on 15 February 2024 for the **MAINTENANCE OF SERVER EQUIPMENT SUBSCRIPTION OF SOFTWARE LICENSES FOR VARIOUS IN-HOUSE DEVELOPED APPLICATION SYSTEMS (13 SUPERMICRO SERVERS, RHEL AND ANTI-VIRUS SUBSCRIPTION)** ("Project") with approved budget for the contract in the amount of **TWO MILLION NINETY-FOUR THOUSAND SEVEN HUNDRED TWENTY-ONE PESOS (PHP2,094,721.00)**;

**WHEREAS**, the Invitation to Bid and the bidding documents for Project under Public Bidding No. 2024-009 was posted in PhilGEPS on 17 February 2024. The same ITB was posted in Securities and Exchange Commission (SEC) website and in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 11 March 2024;

**WHEREAS**, on or before the deadline, only **Infostorage Corporation (Infostorage)** submitted its bid in the amount of ₱1,998,429.49 and was declared to have passed the eligibility requirements during the preliminary examination of bids;

**WHEREAS**, after the necessary bid evaluation on the same date, the bid of Infostorage was determined and declared as the Single Calculated Bid, and notice was sent to the latter requiring its submission post-qualification documents;


**WHEREAS**, on 01 April 2024, and after post-qualification, the bid of Infostorage was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

**NOW, THEREFORE**, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

1. To declare the bid of **INFOSTORAGE CORPORATION** in the amount of **ONE MILLION NINE HUNDRED NINETY-EIGHT THOUSAND FOUR HUNDRED TWENTY-NINE PESOS AND 100/49 (₱1,998,429.49)**, inclusive of VAT and all applicable taxes, as the Single Calculated and Responsive Bid for the above-mentioned projects; and
2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **MAINTENANCE OF SERVER EQUIPMENT SUBSCRIPTION OF SOFTWARE LICENSES FOR VARIOUS IN-HOUSE DEVELOPED APPLICATION SYSTEMS (13 SUPERMICRO SERVERS, RHEL AND ANTI-VIRUS SUBSCRIPTION)**, under Public Bidding No. 2024-009, be awarded to **INFOSTORAGE CORPORATION**.


