

## DECLARATION OF SINGLE CALCULATED AND RESPONSIVE BID AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-069)

**WHEREAS**, Purchase Request No. 202402106 (Annex A) were received on 22 February 2024 for the **SUPPLY OF PRINTING SERVICES (High Speed Printers)** with approved budget for the contract in the amount of **Five Million Five Hundred Fifty-Three Thousand Three Hundred Thirty-Five Pesos (Php 5,553,335.00)**;

**WHEREAS**, the Invitation to Bid and the bidding documents for **SUPPLY OF PRINTING SERVICES (High Speed Printers)** under Public Bidding No. 2024-013 was posted in PhilGEPS on 29 February 2024 for the abovementioned procurement. The same IB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 22 March 2024;

**WHEREAS**, on or before the deadline, only **U-BIX CORPORATION (Ubox)** submitted its bid in the amount of **₱5,280,000.00** and was declared to have passed the eligibility requirements during the preliminary examination of bids;

**WHEREAS**, after the necessary bid evaluation, it was found that the bid of Ubox as calculated **₱5,000,280.00** based on the amount in words in accordance with section 32.2.3 and 34.4 of 2016 Revised IRR of RA9184;

**WHEREAS**, the bid of Ubox was determined and declared as the Single Calculated Bid, and notice was sent to the latter requiring its submission post-qualification documents;

**WHEREAS**, on 15 April 2024, and after post-qualification, the bid of Ubox was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

**NOW, THEREFORE**, foregoing considered, the Bids and Awards Committee **RESOLVES** the following;

1. To declare the bid of Ubox in the amount of **Five Million Two Hundred Eighty Pesos (₱ 5,000,280.00)**, all inclusive of VAT and applicable taxes, as the Single Calculated and Responsive Bids for the above-mentioned projects; and
2. To recommend to the Head of the Procuring Entity/Authorized Representative that the contract for the **SUPPLY OF PRINTING SERVICES (High Speed Printers)** under Public Bidding No. 2024-013, be awarded to U-BIX CORPORATION.


