

**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND
RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-077)

WHEREAS, Purchase Request No. 202404235 (Annex A) was received on 16 April 2024 for the **Supply, Delivery, Installation, Configuration, and Training of Biometric System** with an approved budget for the contract in the amount of **EIGHT HUNDRED TEN THOUSAND PESOS (P810,000.00)**;

WHEREAS, Request for Quotation AMP No. 2024-043 was posted in PhilGEPS on 19 April 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in the Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of SEC on the same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 25 April 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;




