

**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION
AND RECOMMENDING AWARD OF CONTRACT**
(Resolution No. 2024-085)

WHEREAS, Purchase Request No. 202404288 (Annex A) was received on 19 April 2024 for the **Engagement of a Learning Service Provider for the Conduct of SEC Onboarding Program 2.0 Module 4: Completed Staff Work ("Project")** with an approved budget for the contract in the amount of **THREE HUNDRED TWENTY THOUSAND PESOS (P320,000.00)**;

WHEREAS, Request for Quotation AMP No. 2024-046 (Lot 2) was posted in PhilGEPS on 24 April 2024 for the Project (Annex B is proof). The same RFQ was posted in the Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of SEC on the same date;
