

**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION
AND RECOMMENDING AWARD OF CONTRACT**
(Resolution No. 2024-083)

WHEREAS, Purchase Request No. 202404287 (Annex A) was received on 19 April 2024 for the **Engagement of a Learning Service Provider for the Conduct of SEC Onboarding Program 2.0 Module 1: Values Reflection Training ("Project")** with an approved budget for the contract in the amount of **ONE HUNDRED SIXTY THOUSAND PESOS (P160,000.00)**;

WHEREAS, Request for Quotation AMP No. 2024-046 (Lot 1) was posted in PhilGEPS on 24 April 2024 for the Project (Annex B is proof). The same RFQ was posted in the Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of SEC on the same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 24 April 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations - i.e. 30 April 2024, 12:00 P.M. - the following quotations were received and opened (Annex D is Abstract of Quotations):


