DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-076)

WHEREAS, Purchase Request Nos. 202403128 & 202403129 (Annex A) was received on 25 March 2024 for the **Supply and Delivery of NAS Solid State Drive (SSD) and External Solid State Drive (SSD) - Reposting** with approved budget for the contract in the amount of **Ninety-Five Thousand Pesos (Php95,000.00)**;

WHEREAS, Request for Quotation No. 2024-045 was posted in PhilGEPS on 16 April 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

WHEREAS, after verification and validation of the quotation on 26 March 2024 (Annex E is Evaluation Report), it was determined that the quotation of **NS23 General Merchandise** in the amount of **P94,050.00** is the single calculated and responsive quotation for the subject procurement.
