**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT**

(Resolution No. 2024-100)

**WHEREAS**, Purchase Request No. 202405351 (Annex A) was received on 04 June 2024 for the **Supply and Delivery of Waterproofing Materials for SEC Ortigas Building** with approved budget for the contract in the amount of **Eight Hundred Twenty Thousand Pesos (Php820,000.00)**;

**WHEREAS**, Request for Quotation No. 2024-061 was posted in PhilGEPS on 05 June 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 05 June 2024, invited (Annex C is proof) the legally, technically, and financially capable service providers;

**WHEREAS**, on or before the deadline to submit quotation/s on 10 June 2024 at 10:00 AM, the below quotations were received and opened (Annex D is Abstract of Quotation):



**WHEREAS**, after verification and validation of the quotations on 10 June 2024 (Annex E is Evaluation Report), it was determined that the quotation of **Boston Builder's Center** in the amount of **Six Hundred Twenty-Six Thousand One Hundred Seventy-Five Pesos (P626,175.00)** is the lowest calculated and responsive quotation for the subject procurement.
