

DECLARATION OF LOWEST CALCULATED AND RESPONSIVE BIDDERS AND RECOMMENDING AWARDS OF CONTRACTS

(Resolution No. 2024-101a)

WHEREAS, Purchase Request No. 202406362 was received on 02 May 2024 for the **SUPPLY AND DELIVERY OF VARIOUS TOOLS AND MATERIALS FOR 16TH FLOOR RENOVATION - Phase 1** ("Project") with approved budget for the contract in the amount of **Six Million Six Hundred Forty-Nine Thousand Pesos (Php 6,649,000.00)**;

WHEREAS, Competitive Bidding was undertaken for the Project, and before the deadline on 31 May 2024 at 11:00am, the following bidders submitted their bids which received the corresponding remarks for Lot 2: Electrical Works, with the approved budget for the contract of **One Million Seven Hundred Three Thousand Pesos (Php 1,703,000.00)**:

WHEREAS, after the necessary bid evaluation on 10 June 2024, it was determined that the bid of MZR Unica, Inc. is *non-responsive* pursuant to Section 32.2.1 of the 2016 revised implementing rules and regulations of RA No. 9184;

WHEREAS, in its Resolution No. 2024-101 dated 14 June 2024, the Bids and Awards Committee resolved "*to proceed with the post-qualification evaluation on the bid of the second lowest calculated bidder for Lot 2: Electrical Works, "A3 Trading and Allied Services Inc."*";

WHEREAS, on 27 June 2024, and after post-qualification, it was observed that the sample submitted by the A3 Trading and Allied Services Inc., did not comply with the minimum technical specifications;

WHEREAS, pursuant to Section 34.3.b of the above-mentioned law, *A3 Trading and Allied Services Inc.*, was declared post-disqualified and the corresponding Notice was issued on 02 July 2024;

WHEREAS, on 8 July 2024 and after the conduct of post-qualification evaluation on the bid of the next lowest bidder, **Clearshot Builders, OPC.**, was determined to be responsive to all requirements and was established to be compliant with all the legal, technical and financial requirements;

NOW, THEREFORE, foregoing considered, the Bids and Awards Committee **RESOLVES** the following:

1. to declare the bid of Clearshot Builders, OPC. in the amount **One Million Three Hundred Forty-Three Thousand Six Hundred Thirty Pesos (₱1,343,630.00)**, inclusive of VAT and applicable taxes, as the Lowest Calculated and Responsive Bids (LCRB); and
2. to recommend to the Head of the Procuring Entity/Authorized Representative the contract for the Lot 2: Electrical Works of the **SUPPLY AND DELIVERY OF VARIOUS TOOLS AND MATERIALS FOR 16TH FLOOR RENOVATION (Phase 1)**, under Public Bidding No. 2024-020, be awarded to the above-mentioned bidder.
