**DECLARATION OF LOWEST CALCULATED AND RESPONSIVE QUOTATION AND
RECOMMENDING AWARD OF CONTRACT**
(Resolution No. 2024-103)

WHEREAS, Purchase Request No. 202405348 (Annex A) was received on 23 May 2024 for the **Supply, Delivery, and Installation of 3 Tonner Floor Mounted Inverter Type Air Conditioning Units for SEC Tarlac Extension Office** with an approved budget for the contract in the amount of **THREE HUNDRED EIGHTY THOUSAND PESOS (P380,000.00)**:

WHEREAS, Request for Quotation AMP No. 2024-059 was posted in PhilGEPS, on 28 May 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in the Securities and Exchange Commission (SEC) website and/or in a conspicuous place inside the premises of SEC on the same date;

WHEREAS, in compliance with Republic Act No. 9184 and its implementing rules and regulations, the Bids and Awards Committee Secretariat, on 28 May 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

WHEREAS, on or before the deadline to submit quotations - i.e. 03 June 2024, 5:00 P.M. - the following quotations were received and opened (Annex D is Abstract of Quotations):
