### DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

**WHEREAS**, Purchase Request No. 202406381 (Annex A) was received on 03 July 2024 for the **Engagement of Service Provider for Catering Services for the APRPC Phase 1: Focus Group Discussion (FGD)** with approved budget for the contract in the amount of **Five Hundred Thousand Pesos (Php 500,000.00)**;

**WHEREAS**, Request for Quotation AMP No. 2024-069 was posted in PhilGEPS on 05 July 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
