### DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND RECOMMENDING AWARD OF CONTRACT

(Resolution No. 2024-109)

**WHEREAS**, Purchase Request No. 202406374 (Annex A) was received on 28 June 2024 for the **Supply of Goods and Services for the Implementation of SEC Forest Project** with approved budget for the contract in the amount of **Three Hundred Eighty-Four Thousand Four Hundred Twenty Pesos (Php 384,420.00)**;

**WHEREAS**, pursuant Section 53.12 of the Republic Act No. 9184 and its implementing rules and regulations, Negotiated Procurement through Community Participation may be resorted to for project/s:

*"Where, in the interest of project sustainability or to achieve certain specific social objectives, it is desirable in selected projects, or its components, to call for participation of local communities through Community or Social Groups, or members thereof in the delivery of Goods and Simple Infrastructure Projects, subject to the Guidelines issued by the GPPB"*

**WHEREAS**, Request for Quotation No. 2024-065 was posted in PhilGEPS on 29 June 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;

**WHEREAS**, in compliance with the above-mentioned law, the Bids and Awards Committee Secretariat, on 01 July 2024, invited (Annex C is proof) the legally, technically, and financially capable suppliers;

**WHEREAS**, on or before the deadline to submit quotations – i.e. 02 July 2024, 08:00 AM – only the quotation from *Briquettor Association of the Philippines, Inc.*, in the amount **P384,420.00** was accepted and opened (Annex D is Abstract of Quotation);

**WHEREAS**, on 04 July 2024 and after post-qualification, the bid of Briquettor Association of the Philippines, Inc., was determined to be responsive to all requirements and established to be compliant with all the legal, technical and financial requirements;

**NOW, THEREFORE**, we, the members of the Bids and Awards Committee, hereby resolve to declare the quotation of **Briquettor Association of the Philippines, Inc.**, in the amount of **Three Hundred Eighty-Four Thousand Four Hundred Twenty Pesos (P384,420.00)** as the single calculated and responsive quotation for the **Supply of Goods and Services for the Implementation of SEC Forest Project**, and to recommend to the Head of the Procuring Entity/Authorized Representative the award of contract to the same bidder in accordance with the terms and conditions of the Request for Quotation No. AMP 2024-065 and accepted quotation.


