**DECLARATION OF SINGLE CALCULATED AND RESPONSIVE QUOTATION AND  
RECOMMENDING AWARD OF CONTRACT**

**WHEREAS**, Purchase Request No. 202406380 (Annex A) was received on 28 June 2024 for the **Procurement of Catering Services for the SEC Sustainability Events** with approved budget for the contract in the amount of **Six Hundred Thousand Pesos (Php 600,000.00)**;

**WHEREAS**, Request for Quotation No. 2024-067 was posted in PhilGEPS on 06 July 2024 for the abovementioned procurement (Annex B is proof). The same RFQ was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on same date;
