The same ITB was posted in Securities and Exchange Commission (SEC) website and/or in conspicuous place inside the premises of SEC on the same date;

WHEREAS, all the mandatory activities before the deadline to submit bids were undertaken and the deadline to submit was scheduled on 10 July 2024;

WHEREAS, on 09 July 2024, SEC issued a Notice of Postponement, rescheduling the submission and opening of bids to 19 July 2024 due to further review of the terms of reference;

1. To declare the bids of the following bidders as the Lowest Calculated and Responsive Bids for each lot number:




